RE: Consider for Approval the Bid from CertaPro Painters for Bid Reference Number 20-IRFB-001 for the Wright Cuney Outdoor Basketball Court Pavilion Painting project. Authorizing the City Manager to Execute all Necessary Documents upon Final Approval by the City Attorney.

I. Background

- A. In June 2019 City Council approved the reallocation of Community Development Block (CDBG) funds (Program Years 2011-2018) for improvements to the Parks and Recreation Departments recreation centers and parks located in low-moderate income neighborhoods.
- B. Wright Cuney Park is located in a low-moderate income neighborhood and is eligible for CDBG funding.
- C. Wright Cuney Park has a covered outdoor basketball court that is more than 20 years old and in need of new paint and new basketball goals.
- D. Repainting the outdoor basketball court at Wright Cuney Park was identified as a project that would fulfill a need and benefit the community.
- E. On January 21, 2020 staff solicited bids, Bid Reference #20-IRFB-001 to prepare and paint the Wright Cuney outdoor basketball court and replace the basketball goals.
- F. Bid Amounts were;
 - CertaPro Painters – \$29,948.44
 - Immaculate Painting & Construction - \$32,147.39
 - JNA Painting & Contracting - \$34,933
 - Flamingo Gardens - \$38,900.00

II. Current Situation

- A. The Wright Cuney outdoor basketball court is more than 20 years old and is in need of new paint and replacement of its basketball goals.
- B. In June of 2019 Council approved the reallocation of CDBG funds to improve recreation centers and parks located in low-moderate income neighborhoods.
- C. The Wright Cuney Recreation Center and outdoor basketball court are located in a low-moderate income neighborhood and qualify for CDBG funds.


